## Joint Establishment of Regional Revitalization Partners Co., Ltd.

Tokyo (Thursday, August 27, 2020) --- Shinsei Bank, Limited (hereinafter, "Shinsei Bank") will jointly establish Regional Revitalization Partners Co., Ltd. ("Regional Revitalization Partners") on August 31 2020, with SBI Holdings, Inc., Concordia Financial Group, Ltd., Development Bank of Japan, Inc. and Yamaguchi Financial Group, Inc. as an entity to promote regional revitalization initiatives.

### 1. Purpose of the Joint Establishment

As announced in the June 8, 2020 news release\*, we agreed with SBI Holdings, Inc. in terms of engaging in regional revitalization and have been considering the establishment of Regional Revitalization Partners jointly with partner companies with whom we can share our ideas to realize regional revitalization.

Regional Revitalization Partners will play a key role jointly to plan and promote the projects for regional revitalization, and it will be the main entity to contribute to the revitalization of regional economies. Regional Revitalization Partners will be the foundation to accelerate the initiatives to contribute to regional revitalization by integrating management resources of various business corporations, financial institutions and local governments to bring together their knowledge and expertise.

Through this project, the Shinsei Bank Group will develop a new normal by not only revitalizing local economies but also by overcoming the negative impacts of COVID-19. In addition, the Shinsei Bank Group is to provide its services and functions to regional financial institutions so that it will be able to implement one of its strategies, that is, "Growth Through Value Co-Creation through partnerships with regional financial institutions" set in its Medium-Term Strategies.
