

Shinsei Bank revised Long Term Prime Rate

Tokyo (Monday, April 10, 2006) --- Shinsei Bank, Limited (“Shinsei Bank”) today announced that it changed Long Term Prime Rate as follows, in view of recent economic and financial conditions.
