SBI Hyper Deposit Balance Surpasses ¥1.4 trillion

Tokyo (June 24, 2026) --- SBI Shinsei Bank, Ltd. (Head Office: Tokyo; President and CEO: Katsuya Kawashima; hereinafter “SBI Shinsei Bank”) is pleased to announce that the balance of SBI Hyper Deposit (SBI Hyper Yokin) surpassed ¥1.4 trillion as of June 23, 2026.

SBI Hyper Deposit is a service that seamlessly links deposits at SBI Shinsei Bank with SBI Securities, enabling integrated management of funds for both daily expenses and investment purposes. Balances are automatically reflected as purchasing power when needed, providing a high level of convenience. In addition, customers can earn interest on their deposits while keeping funds readily available for investment opportunities, making it an efficient cash management solution. As a result, within approximately nine months of launch, the service has exceeded ¥1.4 trillion in balances and more than 560,000 accounts.

The Bank also announced on June 16, 2026, that the standard interest rate for SBI Hyper Deposit will be increased from 0.50% per annum (0.3984% after tax) to 0.55% per annum (0.4382% after tax), effective July 10, 2026.

Ahead of this interest rate revision, two campaigns were launched on June 19, 2026, to provide customers with additional benefits:
